What is a Lean Steering Committee and why is it a key element of a company's Lean Transformation

- **Lean Policy Development & Deployment**: Establish the policies, principles, metrics, and guidelines related to the company's lean journey.
- **Resource Allocation**: Facilitate the effective assignment and allocation of resources required for implementing lean practices.
- **Change Management**: Drive cultural transformation within the organization and champion the adoption of lean principles throughout the company.
- **Performance Monitoring & Reporting**: Monitor and communicate the progress and results of lean initiatives to stakeholders.
- **Best Practice Sharing**: Foster knowledge sharing and collaboration across the organization.
- **Continuous Improvement Roadmap**: Develop, refine, and update the organization's lean priorities and timeline.
